
#### Introduction

Animation is a global market due to its popularity across all ages. Each market however, receives animation differently. Due to cultural differences and changes, markets vary according to the age of the viewers. This results in several very specific markets based on a number of changing factors. The most common division in this market is age related.

#### GENERAL AUDIENCE

When I am approached to develop animation programming my first question is always "What is the age of the audience?" The most terrifying answer is "General Audiences".



• "General Audience" means the animation and the story it tells is acceptable to all ages.



## "General Audience" (cont.)

This is generally an unrealistic expectation requiring story elements that are:

- Simple enough to be understood by the youngest members of the audience as well as...
- engaging to the most sophisticated viewer.

This requirement can encompass 70 years of experience, education and historic values.

It is the hardest demographic to hit.

## "General Audience" (cont.)

• "General Audiences" appears to be the goal that most providers of content want to hit but it is not necessary to strive for this difficult to attain ideal.

## "General Audience" (cont.)

Television is divided into markets along specific age ranges.

These markets range from pre-school children to mature adult audiences. Whatever the advertiser is selling, there is a television market for it.

#### American TV and children

TV

American television geared towards children has been a concern among parents since the earliest days of the media. Broadcast television has come under pressure to edit programming to children to ensure that nothing harmful will be viewed by this age group.



## American TV and children (cont.)

TV

Broadcast Standards and Practices was a department created by the Television Networks in response to this concern. Television critics screened all programming to assure compliance to certain approved standards. Early children's television was produced under these guidelines.

## American TV and children (cont.)

TV

These guidelines were judged by parental organizations to be too lax and they demanded strict federal standards to replace commercial network practices. The compromise between censorship and free-market viewing was to allow parents to decide what their children should watch. To make this attainable, a content ratings system was created.

- A Brief History
- The early movies ratings system in the United States was designed to help parents gain information to help them in making decisions about which movies their children will and will not be allowed to watch.

- Once Television programming came on the scene, the need for a similar rating system was desired.
- This TV ratings system was modeled after the ratings system already in place for motion pictures also a voluntary ratings system. While there is occasionally a blanket rating for a show, generally individual episodes are rated for their content by a monitoring board.

TV-G ratings were voluntarily used with broadcast television programs. With the proliferation of programs produced for cable and therefore not under the same restrictions as broadcast television, the concerns voiced by parents resulted in 1996, the USA Federal Communications commission pushed for a ratings system to help guide parents in making viewing decisions for their children.



#### TV-Y

PROGRAMMING AIMED AT THE YOUNGEST AUDIENCES: TV-Y MEANS THAT THE PROGRAM IS SUITABLE FOR ALL CHILDREN. THERE ARE NO FRIGHTENING IMAGES OR SITUATIONS. THERE IS NO UNSUITABLE LANGUAGE. THIS AUDIENCE DEVELOPMENTALLY MAY NOT EASILY DISTINGUISH BETWEEN REAL AND MAKE BELIEVE, SO MORE CARE IS REQUIRED.



#### **TV-Y7**

PROGRAMMING IS DESIGNED FOR AUDIENCES AGED 7 AND ABOVE. PROGRAMMING MAY HAVE EDUCATIONAL THEMES, BUT SOME PROGRAMMING IS TOTALLY FOR ENTERTAINMENT PURPOSES. MAY HAVE MILD/COMEDIC FANTASY OR VIOLENCE - PARENTS SHOULD CONSIDER THE APPROPRIATENESS OF THE PROGRAM FOR CHILDREN YOUNGER THAN 7 YEARS.

### THE "V" CHIP DEVICE

- WITH SO MANY AVENUES OF TV-MA PROGRAMMING, SINCE 2000, MANUFACTURERS HAVE INCLUDED A V-CHIP DEVICE BUILT INTO THE TV SET.
- THIS V-CHIP ALLOWS PARENTS TO DIGITALLY PREVENT VIEWING OF PROGRAMMING THAT HAS A TV RATING OF ANY TYPE THEY WISH TO BLOCK.

### THE "V" CHIP DEVICE (cont.)

HOW THE V-CHIP FUNCTIONS: THE V-CHIP DEVICE DIGITALLY 'RECOGNIZES' THE RATINGS ON A SHOW BEING BROADCAST. PARENTS CAN PROGRAM THEIR SETS TO KEEP OUT SHOWS WITH A PARTICULAR RATING.



- THE MARKET PLACE. Where do you place your product? Do your homework and research.
- For example, you shouldn't approach **Disney** with a show that obviously falls into the **TV-MA** category. They don't produce or distribute such programming. They produce with a "family audience" in mind.

# WHAT'S REQUIRED FOR A 'G' GENERAL AUDIENCE?

A SHOW AIMED AT A GENERAL AUDIENCE WILL REQUIRE:

- A CLEAR VISION OF SHOW
- . A CLEAR EPISODE IDEAS THAT MATCH VISION
- A VISUAL STYLE CONCEPT
- . STORYLINES THAT APPEAL TO A BROAD RANGE OF AGES
- NOTE: IF YOUR SHOW IDEA HAS EDUCATIONAL ELEMENTS HAVE A CLEAR SET OF *GOALS* THAT ARE PART OF THE OVERALL VISION OF THE SHOW.






